## **REGISTRATION**

1. Bidders are required to enroll on the e-Procurement Portal (URL: **Error! Hyperlink reference not valid.**) by clicking on the link “Online bidder Registration” on the e-tender Portal and paying the Registration fee of Rs. 2360/- per year charge.
2. As part of the enrolment process, the bidders will be required to choose a unique user name and assign a password for their accounts.
3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication with the bidder.
4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Only Class III Certificates with signing + encryption key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC’s to others which may lead to misuse.
6. Bidders then log in to the site through the secured log-in by entering their user ID/password and the password of the DSC / e-Token.
7. The scanned copies of all original documents should be uploaded on portal.

## **SEARCHING FOR TENDER DOCUMENTS**

There are various search options built in the e-Procurement Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Item/work id, Title, Date, etc.

Once the bidders had selected the tenders in which they are interested, bidder can pay the processing fee **Rs.3000/- + 18% GST (NOT REFUNDABLE)** by net-banking / Debit / Credit card and then download the required documents / tender schedules, Bid documents etc. Once you pay both fee, tenders will be moved to the respective “Register” Tab. This would enable the e-Procurement Portal to intimate the bidders through e-mail in case there is any corrigendum issued to the tender document.

### ***1. Introduction:***

The National Institute of Animal Welfare (NIAW), Ballabhgarh, Faridabad (HR), invites e-tenders from the reputed firm/ agency/ contractor for “**Supply and installation of 12.5 Mtrs. Flag Mast at National Institute of Animal Welfare (NIAW), Ballabhgarh, Faridabad (HR)**”. The bidders are advised to compulsorily visit the site to see and understand the requirement of the work before quoting their rates.



## **2. Scope of work:**

The work includes the foundation of the Pole. The bidder will get the bearing capacity tested, before designing the foundation. The design calculation & structural drawing shall also be supplied by the bidder. The design can be got rechecked by the Director (NIAW) & if there is any expenditure on this account the same shall be borne by the bidder.

Arrangement & supply of all materials of appropriate technical specifications and make as stipulated in the Price-Bid, at NIAW site, and satisfactorily installation including the civil foundation works and handing over thereof complete in all respect. The contractor will execute the work in close coordination with the Institute's Officers/ Officials. All safety and security guidelines of the Institute will be followed by the workers deputed by the agency at site.

## **3. Earnest Money Deposit (EMD):**

The Bidder shall furnish EMD of Rs.5,000/- (Rupees Five thousand only) along with the tender in the form of demand draft in favour of "Pay and Accounts Officer, MoEF&CC" payable at New Delhi. EMD shall be returned to the unsuccessful bidders after award of work. The tender not accompanied with EMD shall be rejected.

## **4. Eligibility Criteria :**

The bidders must have satisfactorily completed the similar works i.e. supply and installation of Flag Mast complete in all respect, in the Government sector or large reputed Private firm.

## **5. Submission of Tender:**

The contractor shall submit the tender online in the following manner:

Technical Bid. 1 - shall contain following three ( i to iii ) only.

- i. EMD in the form of demand draft for Rs.5,000/- (Rupees Five thousand only).
- ii. Copy of tender document duly signed and stamped by the bidder as a token of acceptance of terms & conditions and bill of quantity of the tender.
- iii. Work Order/ Completion certificates from client for similar nature of work(s) successfully executed by the bidder.

Technical Bids not accompanied with all above three documents will not be considered and treated as rejected. Conditional bids suggesting alternate material specifications etc. shall be treated non-responsive and not considered for opening of Price Bid.

Financial Bid. 2 - Shall contain Price-Bid. Price shall be filled by the bidder, only in the format given with the tender by NIAW. Price on any other format or in other units or for other product is liable to be rejected.

## **6. Time of Completion:**

The work shall be completed within one month period from the date of issue of work order. Time extension, if required on any account will have to be brought to the notice of Director (NIAW) at least one week in advance from the date of scheduled job completion with proper details & justification.



**7. Liquidated Damages:**

If the contractor fails to complete the work within the stipulated time or time extended by the Institute (if any), liquidated damages at the rate of 1% per week or part thereof of delay subject to maximum 10% of the total contract value shall be deducted /recovered from the contractor.

**8. Payment:**


Full & final payment shall be made on satisfactory completion of work & production of bill by the contractor within a week after completion of work. No advance or running payment thereof shall be made. Taxes as applicable, shall be deducted from the payment as per rule.

**9. Disputes:**

If any dispute or difference of any kind, whatsoever, shall arise between NIAW and the Contractor, in connection with or arising out of the Contract, or execution of the works, whether during the progress of the works or after their completion and whether before or after the termination, abandonment or breach of the contract, it shall, be settled under the Indian Arbitration and Conciliation Act, 1996 or any statutory modification or re-enactment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceedings under this clause. Such arbitration shall be settled by sole arbitrator who shall be appointed by Director, NIAW. The arbitration shall take place in Faridabad/ Delhi unless both parties agree otherwise.

**10. Right to accept or reject the Tender:**

Director (NIAW) reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
