

Decision of Ministry of Environment, Forest and Climate Change with respect to import and export of hazardous and other waste under the provisions of Hazardous and other Wastes (Management and Transboundary Movement) Rules, 2016 as approved by the Competent Authority on the basis of recommendation of 146th Meeting of Expert Committee (EC) held on 24th June, 2025.

PROCEEDINGS

146th Meeting of Expert Committee (EC) for Appraisal of Applications for Import/Export of hazardous and other wastes with reference to Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 as amended from time to time held on 24th June, 2025 through Online mode under the chairmanship of Shri Sudhir Srivastava.

Opening Remarks of the Chairman: The Chairman extended welcome to members and other participants and requested to start the proceeding as per the agenda adopted for this meeting.

Consideration of Proposals: The EC considered the proposals as per agenda adopted for the meeting. The details of deliberations held and decisions taken in the meeting are as under:

AGENDA NO. 1. IMPORT OF LEAD SCRAP/BATTERIES SCRAP **(BASEL NO. B1020/A1160)**

1.1. M/s Planetfirst Green Private Limited, Surat, Gujarat (F.No.23/64/2023-HSMD)

The application (App ID-SW9987824300-M014_D001_A304-1743153967497) pertains to import of 15,000 MT of Lead Scrap/Battery Scrap as per ISRI Code: Radio/Racks/ Ropes/ Rails/ Rents/ Racks/ Rakes/ Rinks/ Rains (A1160/B1020). The applicant has furnished Form 5, Justification for import, Process flow chart indicating adequate pollution control equipment, Lead analysis report in soil, air, water, stack and blood of the workers. The Consent No. and authorization AWH -112438 (Change of name consent No.GPCB/CCA-SRT-2300(2)/ID_75451 dated 08th January, 2024 is valid up to 30th September, 2025. The consented capacity for Lead Ingots is 150 MT/month, Lead Ingots and Refined Lead is 2,000 MT/M. The date of establishment is 19th April, 2024. The Actual date of operation is 29th August, 2021. The production in last FY (2024-2025) was 13,412 MT. The export was 100 MT for FY (2024-25). The previous permission was given for the import of 9,918 MT of Lead scrap/Battery scrap *vide* letter dated 12th April, 2024. The site visit was conducted by CPCB on 12th June, 2023.

Recommendation: Based on the information and details submitted by the applicant, the EC after deliberation on the proposal recommended import of 9,008 MT of Lead Scrap/Battery Scrap as per ISRI Code: Radio/Racks/Ropes/Rails/Rents/Racks/Rakes (B1020) and Rains (A1160) with not more than 2% of liquid/electrolyte by weight in a given lot/consignment/container and Rink (A1160), subject to one-time verification by CPCB regarding availability of suitable technology/process in this regard and the ability of the unit to effectively handle the quantity of Rink/Rains sought to be imported. Further, the quantity of import of RINK will be limited to 50% of the total import quantity recommended. The import of Basel No. A1160 is allowed subject to the Prior Informed Consent (PIC) of the exporting country.

1.2. M/s Mateshwari Metals, Surat, Gujarat (F.No.23/75/2023-HSMD)

The application (App ID-SW24010818571-M014_D001_A304-1744188680452) pertains to import of 1,800 MT Lead Scrap/Battery Scrap (A1160/B1020). The applicant has furnished Form 5, Justification for import, Process flow chart indicating adequate pollution control equipment, Lead analysis report in soil, air, water, stack and blood of the workers. The Consent No. and Authorization No AWH- 135564 dated 10th July, 2024 is valid up to 31st December, 2028. The consented capacity for Lead Ingots is 1,800 MT/year. The Actual date of operation is 1st August, 2019. The production in last FY (2024-2025) is 281.97 MT. The export was nil for FY (2024-25). The previous permission was given for the import of 1,000 MT of Lead scrap/Battery scrap *vide* letter dated 30th August, 2023. The site visit was conducted by CPCB on 13th June, 2023.

Recommendation: Based on the information and details submitted by the applicant, the EC after deliberation on the proposal recommended import of 188 MT Lead Scrap/Battery Scrap (B1020/A1160) subject to one-time verification by CPCB regarding availability of suitable technology/process in this regard and the ability of the unit to effectively handle the quantity of Rink/Rains sought to be imported. Further, the quantity of import of RINK will be limited to 50% of the total import quantity recommended. The import of Basel No. A1160 is allowed subject to the Prior Informed Consent (PIC) of the exporting country.

1.3. M/s Jammu Pigments Limited, Kathua, Jammu and Kashmir (F.No.23-58/2009-HSMD)

The application (App ID-SW9643333277-M014_D001_A304-1749456292222) pertains to import of 22,788 MT Lead Scrap/Battery Scrap (as per ISRI Code: Rails, Racks, Radio, Ropes, Relay, Rents, Rakes, Rinks and Rains) (A1160/B1020). The applicant has furnished Form 5, Justification for import, Process flow chart indicating adequate pollution control equipment, Lead analysis report in soil, air, water, stack and blood of the workers. The Consent No. and Authorization No PCC/digital/210614294435 of 2024 dated 17th August, 2024 is valid up to March, 2029. The consented capacity for Lead Ingot/Lead Alloy/lead Sinter/Lead Block is 22,788 MT/year, Copper Cathode/Copper Sulphate/Cadmium Metal/Cadmium Alloy/Zinc Alloy is 210 MT/year – 210 MT/Year, Zinc Oxide/ Zinc Alloy is 6,058 MT/Year. The date of establishment is 29th August, 2005. The Actual date of operation is 03th June, 2007. The production in last FY (2024-2025) is 22,573.809 MT. The export was 4,480.84 for FY (2024-25). The previous permission was given for the import of 9,330 MT & 9,360 MT of Lead scrap/Battery scrap *vide* letter dated 16th January, 2024 and 15th February, 2024 respectively. The site visit was conducted by CPCB on 29th January, 2024.

Recommendation: Based on the information and details submitted by the applicant, the EC after deliberation on the proposal recommended import of 18,036 MT Lead Scrap/Battery Scrap (as per ISRI Code: Rails, Racks, Radio, Ropes, Relay, Rents, Rakes (B1020), Rains (A1160) with not more than 2% of liquid/electrolyte by weight in a given lot/consignment/container and Rink (A1160). Further, the quantity of import of RINK will be limited to 50% of the total import quantity recommended. The import of Basel No. A1160 is allowed subject to the Prior Informed Consent (PIC) of the exporting country.

1.4. M/s Shree Ponni Lead Alloy Pvt Ltd, Ramanagara, Karnataka (F.No.23/32/2020-HSM)

The application (App ID-SW9999480564-M014_D001_A304-1749540665494) pertains to import of 45,000 MT Lead Scrap/Battery Scrap (as per ISRI code Rono, Roper, Racks, Relay, Rakes, Radio, Reels, Rents, Rails, Rink, Rains). The applicant has furnished Form 5, Justification for import, Process flow chart indicating adequate pollution control equipment, Lead analysis report in soil, air, water, stack and blood of the workers. The Consent No. AW-325745 dated 06th July, 2021 is valid up to 30th June, 2026 and The Authorization No. 328319 dated 24th November, 2021 is valid up to 30th June, 2026. The consented capacity for Lead ingots is 3,166 MT, Lead sub oxide is 125 MT and Reprocessing of used lead batteries/lead scrap is 3,750 MT. The date of establishment is 10th August, 2011. The Actual date of operation is 06th April, 2017. The production in last FY (2024-2025) is 32,019 MT. The export was 1,073 MT for FY (2024-25). The previous permission was given for the import of 20,758 MT of Lead scrap/Battery scrap *vide* letter dated 28th May, 2024. The site visit was conducted by CPCB on 10th February, 2024.

Recommendation: Based on the information and details submitted by the applicant, the EC after deliberation on the proposal recommended import 22,061 MT Lead Scrap/Battery Scrap (as per ISRI code Rono, Roper, Racks, Relay, Rakes, Radio, Reels, Rents, Rails (B1020), Rains (A1160) with not more than 2% of liquid/electrolyte by weight in a given lot/consignment/container and Rink (A1160). Further, the quantity of import of RINK will be limited to 50% of the total import quantity recommended. The import of Basel No. A1160 is allowed subject to the Prior Informed Consent (PIC) of the exporting country.

1.5. M/s Starsun Alloys Private Limited, Bulandshahar, Uttar Pradesh (New Application)

The application (App ID-SW2403889707-M014_D001_A304-1742483687278) pertains to import of 60,000 MT Lead Scrap/Battery Scrap (as per ISRI code Radio/Racks/Ropes/Relay/Rents/Racks/Rails/Rains). The applicant has furnished Form 5, Justification for import, Process flow chart indicating adequate pollution control equipment, Lead analysis report in soil, air, water, stack and blood of the workers. The Consent No. and The Authorization No 218753/UPPCB/Bulandshahar (UPPCBRO)/CTO/both/ BULAND SHAHAR/2024 dated 03rd September, 2024 is valid up to 31st December, 2028. The consented capacity for Lead Ingots & Red oxide, Grey lead oxide is 4,000 MT/month. The Actual date of operation is 03rd September, 2024.

It is to mention that the name mentioned in the CTO dated 31.01.2022 submitted by the applicant is M/s Sunrise Metal Industries. However, the name mentioned in another Consolidated Consent and Authorization dated 03.09.2024 provided by them is in the name of M/s Starsun Alloys PVT LTD.

As, the new CTO dated 03.09.2024 submitted by the applicant does not mention anything about name change of the unit, therefore it was requested to provide CCA copy clearly indicating name change of the unit. The applicant then informed that they have not changed the name of Sunrise Metal, but have instead obtained a new registration under the name Starsun Alloys Pvt. Ltd. and also obtained fresh consent under the name of Starsun Alloys Pvt. Ltd.

Recommendation: Based on the information and details submitted by the applicant, the EC after deliberation on the proposal debated whether to reject the

proposal as per the policy for new application that the CTO should be at least one and a half year old for consideration of application. Further, applicant was not present during the meeting to clarify the doubts. However, in order to provide an opportunity, EC recommended that details of the company regarding taking over the M/s Sunrise Metal Industries may be asked from the applicant and also recommended site visit by CPCB to check and verify compliance of SOP. Till then the matter is deferred.

1.6. M/s Leadstone Energy Ltd, Hooghly, West Bengal (F.No.23/13/2010-HSMD)

The applicant has requested for the extension of validity period of permission granted for import of 3,000 MT of Lead Scrap (as per ISRI Code: Radio, Racks, Ropes, Rails, Rents, Rakes, Relay) (B1020) vide letter dated 13th November, 2023 by at least Six months. It is mentioned that they could not import the full-approved quantity due to some reasons and have imported only 409.500 MT out of the 3,000 MT so far.

Recommendation: The EC after deliberation on the proposal, recommended extension of validity for 06 months from the date of expiry of the permission granted for import of 3,000 MT of Lead Scrap (as per ISRI Code: Radio, Racks, Ropes, Rails, Rents, Rakes, Relay) (B1020) vide letter dated 13th November, 2023 i.e. up to 12th November, 2025. No further extension will be given.

1.7. M/s Nile Ltd, Tirupati, Andhra Pradesh (F.No.23-139-2014-HSMD)

The applicant has requested for the extension of validity period of permission granted for import of 23,505 MT of Lead Scrap (as per ISRI Code: Radio, Racks, Ropes, Rails, Rents, Rakes, Relay, Roses, Rono, Roper, Rains, Lead Grids, Lead Paste, Lead Powder, Lead Oxide and other lead waste scrap and Rink) (B1020/A1160) vide letter dated 12th April, 2024 by at least Six months. It is mentioned that they had received the Prior Informed Consent (PIC) for the transboundary notification for Import of 5,000 MT of RINKS and RAINS from KBI recycling USA, one year after the exporter has submitted the request to USEPA. Due to delay in sending of the same by US State Department, the last date of shipment in that PIC as forwarded and sent by the USEPA and approved by MoEF&CC has already lapsed by the time we received the PIC, i. e on 20.05.2025.

Due to this delay of the US state department and late receipt of the approved PIC, we could not import any quantity against our present MoEF&CC permission which we had planned for import from the USA.

KBI Recycling, USA has now initiated a fresh request for Prior Informed Consent (PIC)/Transboundary Notification. However, our current MoEF&CC Import Permission is valid only until 11.10.2025. Given the time typically required for the PIC approval process, it is likely that the validity of our permission will have expired or be close to expiry by the time the new PIC is issued. This would again render the approved PIC unusable for import purposes.

Applicant, therefore request Ministry to grant an extension of 6 months, i.e. till 11th April 2026 of our current MoEF&CC import permission to enable us to get the PIC accordingly and to have sufficient time to complete the planned imports from the USA.

Recommendation: The EC after deliberation on the proposal, recommended extension of validity for 06 months from the date of expiry of the permission granted for import of 23,505 MT of Lead Scrap (as per ISRI Code: Radio, Racks, Ropes, Rails, Rents, Rakes,

Relay, Roses, Rono, Roper, Rains, Lead Grids, Lead Paste, Lead Powder, Lead Oxide and other lead waste scrap and Rink) (B1020/A1160) *vide* letter dated 12th April, 2024 i.e. up to 11th April, 2026. No further extension will be given.

AGENDA NO. 2: IMPORT OF USED RUBBER TYRES SCRAP (BASEL NO. B3140/B3080/B3040)

Initial Discussion – The EC was of the opinion that Ministry may ask applicants to provide Input Tax Credit (ITC) details in the GST CA certificate provided by them from next meeting onwards.

2.1 M/s Renovex Industries LLP, Morbi, Gujarat (New Application).

The application (App ID-SW0080381055-M014_D001_A304-1749719631207) pertains to import of 5,000 MT of old/used rubber tyre scrap/tube scrap (B3080 & B3140). The applicant has furnished Form 5, Process flow chart indicating adequate pollution control equipment. The Consent to Operate No. and authorization No. AWH-81793 dated 05th April, 2025 is valid up to 31st March, 2027. The consented capacity for Crumb Rubber is 1500 MT/month. The date of establishment is 11th January, 2025. The actual date of operation is 05th April, 2025.

Recommendation: Based on the information/details submitted by the applicant, the EC after deliberation on the proposal, recommended import of 1,500 MT of old/used rubber tyre scrap/tube scrap (B3080 & B3140). Further, the aforesaid recommended quantity may be granted after submission of site visit report by CPCB stating compliance of SOP without referring the application to the EC.

2.2 M/s GT Rubber Product Pvt Ltd, Dhule, Maharashtra (New Application).

The application (App ID-SW24012244077-M014_D001_A304-1749725879599) pertains to import of 5,000 MT of old/used rubber tyre scrap/tube scrap (B3140 and B3080). The applicant has furnished Form 5, Process flow chart indicating adequate pollution control equipment. The Consent to Operate No. and authorization No. ORANGE/ S.S.I () No:- Format 1.0/ RO/ UAN No. 0000212452/ CO/ 2504000932 dated 07th April, 2025 is valid up to 28th February, 2029. The consented capacity for Crumb Rubber Powder is 520 MT/M. The date of establishment 12th June, 2023 and the actual date of operation is 07th April, 2025.

Recommendation: Based on the information/details submitted by the applicant, the EC after deliberation on the proposal, recommended import of 624 MT of old/used rubber tyre scrap/tube scrap (B3080 & B3140). Further, the aforesaid recommended quantity may be granted after submission of site visit report by CPCB stating compliance of SOP without referring the application to the EC.

2.3 M/s Chennai Crumb Industries, Tiruvallur, Tamil Nadu (F.No.23/19/2023HSMD).

The application (App ID-SW2405324577-M014_D001_A304-1749454204383) pertains to import of 15,000 MT of old/used rubber tyre scrap/tube scrap (B3040). The applicant has furnished Form 5, Process flow chart indicating adequate pollution control equipment. The Consent to Operate No. 2205245542885 dated 26th July, 2022 is valid up

to 31st March, 2028 and authorization No. 22HFC46943004 dated 22nd February, 2022 is valid up to 31st March, 2027. The consented capacity for Crumb Rubber is 2,100 T/Month. The date of establishment is 07th October, 2021 and the actual date of operation is 18th July, 2022. The production in last FY (FY 2024-25) is 16,850 MT. The unit has connected load of 112 KVA and electricity bill Rs.1,15,42,250/- in FY 2024-2025. GST of Rs.4,32,51,042/- was paid by the applicant during FY 2024-2025. The domestic purchase was 7,256.641 MT out of 16,583.311 MT (FY 2024-25). The previous permission was given for the import of 9,539 MT of Used Rubber Tyre/Tube Scrap *vide* letter dated 03rd July, 2024. The site visit was conducted by CPCB on 04th January, 2023.

Recommendation: Based on the information/details submitted by the applicant, the EC after deliberation on the proposal, recommended import of 11,233 MT of old/used rubber tyre scrap/tube scrap (B3040).

2.4 M/s Gayathree Industries, Medchal, Telangana (F.No.23/35/2019 -HSMD).

The application (App ID-SW8926714641-M014_D001_A304-1749473086318) pertains to import of 30,000 MT of old/used rubber tyre scrap/tube scrap (B3040/B3080/B3140). The applicant has furnished Form 5, Process flow chart indicating adequate pollution control equipment. The Consent to Operate No. and authorization No.1150-RR-II/TSPCB/ZOH/TS-iPass/CFO/2023-478 dated 04th November, 2023 is valid up to 31st August, 2028. The consented capacity for Crumb rubber/Chips is 23,000 TPA. The production in last FY (FY 2024-25) was 9,350 MT. The export was nil. The unit has Connected load of 90 KVA/HP and Electricity bill paid was Rs.49,52,000/- and bill paid for other fuel id Rs.13,85,000/- in FY 2024-2025. GST of Rs.1,90,67,882/- was paid by the applicant during FY 2024-2025. The domestic purchase was 5,000 MT out of 10,050 MT (FY 2024-25). The previous permission was given for the import of 3,640 MT (additional quantity) of Used Rubber Tyre/Tube Scrap *vide* letter dated 07th February, 2025. The site visit was conducted by CPCB on 26th July, 2023.

Recommendation: Based on the information/details submitted by the applicant, the EC after deliberation on the proposal, recommended import of 6,233 MT of old/used rubber tyre scrap/tube scrap (B3040/B3080/B3140).

2.5 M/s Michy Industries, Kolar, Karnataka (F.No.23/56/2024 -HSMD).

The application (App ID-SW5652902319-M014_D001_A304-1749453521930) pertains to import of 15,000 MT of old/used rubber tyre scrap/tube scrap (B3040). The applicant has furnished Form 5, Process flow chart indicating adequate pollution control equipment. The Consent to Operate No and authorization No. AW-338430 Dated 03rd July, 2023 is valid up to 30th September, 2032. The consented capacity for Crumb rubber powder is 3,250 MT/month. The date of establishment is 07th October, 2021 and the actual date of operation is 01st July, 2023. The production in last FY (FY 2024-25) was 18,200 MT. The export was nil. The unit has connected load of 300 KVA and respective electricity bill is Rs.1,23,76,000/- in FY 2024-2025. GST of Rs.4,54,28,907/- was paid by the applicant during FY 2024-2025. The domestic purchase was 17,740 MT out of 19,240 MT (FY 2024-25). The previous permission was given for the import of 1,500 MT of Used Rubber Tyre/Tube Scrap *vide* letter dated 21st March, 2025. The site visit was conducted by CPCB on 08th December 2023.

Recommendation: Based on the information/details submitted by the applicant, the EC after deliberation on the proposal, recommended

import of 12,133 MT of old/used rubber tyre scrap/tube scrap (B3040).

2.6 M/s Shiv Sai Technical Industries, Medchal, Telangana (F.No.23/70/2023-HSM).

The application (App ID-SW9999790442-M014_D001_A304-1749463513227) pertains to import of 60,000 MT of old/used rubber tyre scrap/tube scrap (B3080/B3140/B3040). The applicant has furnished Form 5, Process flow chart indicating adequate pollution control equipment. The Consent to Operate No and authorization No. 1737-RR-II/ TSPCB/ ZOH/ TS-iPass/CFO/2023-479 dated 04th November, 2023 is valid up to 31st August, 2028. The consented capacity for Crumb Rubber Powder is 27,000 TPA & Crumb Rubber Chips is 27,000 TPA. The actual date of operation is 18th November, 2022. The production in last FY (FY 2024-25) is 9,250 MT. The export is nil. The unit has connected load of 111 KVA/HP and respective electricity bill paid is Rs.47,80,478/- and DG Set bill paid was Rs.12,85,000 in FY 2024-2025. GST of Rs.1,41,26,014/- was paid by the applicant during FY 2024-2025. The domestic purchase was 5,000 MT out of 9,950 MT (FY 2024-25). The previous permission was given for the import of 3,500 MT (additional quantity) of Used Rubber Tyre/Tube Scrap *vide* letter dated 21st March, 2025. The site visit was conducted by CPCB on 31st March, 2023.

Recommendation: Based on the information/details submitted by the applicant, the EC after deliberation on the proposal, recommended import of 5,990 MT of old/used rubber tyre scrap/tube scrap (B3080 & B3140).

2.7 M/s Classic Rubber, Mehsana, Gujarat (F.No.23/121/2021 -HSM).

The application (App ID-SW9999789950-M014_D001_A304-1749714658300) pertains to import of 50,000 MT of old/used rubber tyre scrap/tube scrap (B3080 & B3140). The applicant has furnished Form 5, Process flow chart indicating adequate pollution control equipment. The Consent to Operate No and authorization GPCB/MEH/CCA-MH-2479/ID-72306/7597: AWH -79815 dated 19th May, 2025 is valid up to 09th January, 2030. The consented capacity for Crumb rubber Sheet is 1,920 MT, Rubber Granulates is 4,700 MT, Rubber Chips/Match is 5,200MT. The date of establishment is 26th August, 2019. The actual date of operation is 10th October, 2019. The production in last FY (FY 2024-25) is 76,110 MT. The export is nil. The unit has connected load of 600 KW and respective electricity bill paid is Rs.5,41,32,221.27/- in FY 2024-2025. GST of Rs.20,47,74,451/- was paid by the applicant during FY 2024-2025. The domestic purchase was 41,128.97 MT out of 83,999.74 MT (FY 2024-25). The previous permission was given for the import of 10,000 MT (Additional quantity) of Used Rubber Tyre/Tube Scrap *vide* letter dated 24th March, 2025. The site visit was conducted by CPCB on 31st January, 2025.

Recommendation: Based on the information/details submitted by the applicant, the EC after deliberation on the proposal, recommended import of 50,000 MT of old/used rubber tyre scrap/tube scrap (B3080 & B3140). Further, 50% or 25,000 MT, whichever is less, of the aforesaid recommended quantity (i.e. 25,000 MT) may be granted now and the rest (i.e. 25,000 MT) may be granted after submission of EPR Compliance details of previous financial year by the applicant and subsequent satisfactory verification report by the CPCB without referring the application to EC again.

2.8 M/s P Square Enterprise, Vadodara, Gujarat (F.No.23/82/2023-HSM).

The application (App ID-SW2405414215-M014_D001_A304-1749721282114) pertains to import of 5,000 MT of old/used rubber tyre scrap/tube scrap (B3140 and B3080). The applicant has furnished Form 5, Process flow chart indicating adequate pollution control equipment. The Consent to Operate No and authorization No. WH - 74499 dated 22nd July, 2024 is valid up to 30th September, 2032. The consented capacity for Granules is 1,050 MT/M. The date of establishment is 10th August, 2022. The actual date of operation is 12th January, 2023. The production in last FY (FY 2024-25) is 3,409.76 MT. The export is nil. The unit has connected load of 100 KW and respective electricity bill paid is Rs.2,38,941/- in FY 2024-2025 and other fuel bill (Solar) is Rs.6,57,486. GST of Rs.2,05,33,646/- was paid by the applicant during FY 2024-2025. The domestic purchase was 3,253.72 MT out of 4,956.04 MT (FY 2024-25). The previous permission was given for the import of 2,545 MT of Used Rubber Tyre/Tube Scrap *vide* letter dated 11th October, 2024. The site visit was conducted by CPCB on 31st May, 2023.

Recommendation: Based on the information/details submitted by the applicant, the EC after deliberation on the proposal, recommended import of 885 MT of old/used rubber tyre scrap/tube scrap (B3140 and B3080). However, EC noted that the GST amount paid in last financial year was very high *vis a vis* production and the applicant was also not present in the meeting for the clarification. Hence, EC asked the applicant to provide the clarification in respect of GST amount paid along with relevant documents. Permission may be given after satisfactory reply received from the applicant without referring to EC again.

2.9 M/s Tejasvini Industries, Hisar, Haryana (F.No.23/34/2023 -HSMD).

However, inadvertently the matter was not included in the agenda of the meeting. Thereafter, applicant requested Ministry for inclusion of their application.
