The undersigned is directed to refer to M/o Railways letter No. 2018/E(O)II/39/10 dated 02.12.2024 and to inform that the Appointments Committee of the Cabinet (ACC) has approved appointment of Shri B. K. Gangte IFS (UTT:1996) to the post of Deputy Director General of Forests (DDGF), Regional Office, Shillong in level 15 of the Pay Matrix, on deputation basis under Central Staffing Scheme of Ministry of Environment, Forest & Climate Change (CSS-MoEFCC) on the following terms and conditions:

- (i) He will draw pay as per the scale allowed by the Cadre Controlling Authority plus Allowances as applicable to that grade.
- (ii) The central deputation tenure of the officer will be till completion of his current deputation tenure on 02.04.2026 w.e.f. the date of assumption of charge or till attaining the age of superannuation, or until further orders, whichever is earliest.
- (iii) The headquarters of the post will be at Shillong, however the services of the officer can be utilized anywhere in India.
- (iv) Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government and as per CSS-MoEFCC.
