I am directed to refer to the subject cited above and to inform that the Appointments Committee of the Cabinet (ACC) has approved appointment of Shri Shivkumar C. M., IFS (HR:2003) to the post of Inspector General of Forests (IGF), National Tiger Conservation Authority, Bangalore in level 14 of the Pay Matrix, on deputation basis under Central Staffing Scheme of Ministry of Environment, Forest & Climate Change (CSS-MoEFCC) on the following terms and conditions:

- (i) He will draw pay as per the scale allowed by the Cadre Controlling Authority plus Allowances as applicable to that grade.
