AGENDA NO. 1. IMPORT OF LEAD SCRAP/BATTERIES SCRAP (B1020/A1160)

1.1. Request for removal of condition i.e. "Prior Informed Consent from the Exporting Countries Required" by M/s Eswari Global Metal Industries Pvt Ltd, Karnataka, Pilot Industries, Alwar and Ardee Industries, Andhra Pradesh - reg.

M/s Eswari Global Metal Industries Pvt Ltd, Karnataka, Pilot Industries, Alwar and Ardee Industries, Andhra Pradesh has requested to reconsider the condition for Basel no. that fall under Part 'A' of Schedule III in the Hazardous and Other Wastes (Management and Transboundary Movement) (HOWM) Rules, 2016 as amended from time to time which mandates the Prior Informed Consent (PIC) from exporting country for import of hazardous waste. However, as per the Basel convention procedures prior inform consent from the importing country is required.

It is mentioned that the purpose of Basel convention is to ensure that the hazardous waste is recycled in an environmental sound recycling facility and the importing country is aware of the import of the waste. Since, MoEFCC has given permission only to environmentally sound recycling facility and without MoEFCC permission copy people cannot import hazardous wastes. They further stated that the permission of MOEFCC for imports might be considered as a Prior Informed Consent from the importing country. Hence, it will avoid any redundancy.

The matter was discussed in 134th meeting of EC and the EC after deliberation on the proposal noted that some of the e-waste processors have indicated that adequate quantity of high quality PCB is not available to them and therefore they have a challenge of capacity utilisation and viability. The applicant, on the other hand, submitted that the commercial terms being offered by domestic processors are not as attractive as being offered by overseas buyers. The EC felt that both these viewpoints had merit and need to be reconciled, and at least some high grade PCB should be supplied in the domestic market along with exports. EC, after deliberation on the proposal recommended that the applicant may be asked to provide details of high grade PCB produced and supplied to the domestic market.

6.1. Representation of M/s Agkem Impex Pvt. Ltd, Delhi regarding import of virgin Titanium Powder Alloys used in Dental Abutments currently being regarded as restricted item being placed all such power under waste category by DGFT/MoEF&CC

M/s Agkem Impex Pvt. Ltd, Delhi *vide* letter dated 19th April, 2024 had requested Ministry to provide clarification regarding import of virgin Titanium powder alloy used for direct human implant abutment, as it is not waste material. They also inform that no waste material can be used for direct human implant other than only virgin titanium powder & its alloys.

The applicant applied to DGFT with details for import of this virgin Titanium powder alloys. But DGFT have referred them to approach MoEFCC for necessary NOC.

The matter was discussed in 133rd meeting of EC and the EC after deliberation on the proposal and hearing the views of applicant recommended that the applicant may provide the manufacturing process of virgin titanium powder from the company & country they want to import and also justify how it is different from the titanium powder mentioned under Basel No. B1031 of Part B Schedule-III of the HOWM Rules, 2016 as amended from time for further discussion/deliberation. Further, the matter was re-discussed in 134th meeting of EC and the EC after discussion deferred the matter for more information/deliberation.

The applicant has now provided the details and so the matter is placed before EC.
